

CENTER FOR VETERINARY HEALTH SCIENCES COLLEGE OF VETERINARY MEDICINE OKLAHOMA STATE UNIVERSITY

Oklahoma State University is located in Stillwater, which is about 65 miles from Oklahoma City and 69 miles from Tulsa. The Center for Veterinary Health Sciences complex includes three major buildings: the Boren Veterinary Medical Teaching Hospital; the Oklahoma Animal Disease Diagnostic Laboratory; and McElroy Hall, which houses classrooms, basic science departments, and the William E. Brock Memorial Library.

CURRICULUM: The first three years of the core-elective curriculum are interdisciplinary and integrated. Electives are offered in years two and three. The fourth year comprises rotations in the veterinary teaching hospital, preceptorships, and electives.

ADMISSION PROCESS: Admission is limited to U.S. citizens and permanent residents. Four positions are reserved for New Jersey residents.

SIZE OF ENTERING CLASS: 80

DEADLINE DATE: October 1, 2005

CLASSES BEGIN: August, 2006

PROCESSING FEE: A nonrefundable \$25 processing and application fee made payable to College of Veterinary Medicine will be assessed to all those applying through VMCAS.

ADMISSION DEPOSIT: A non-refundable deposit paid at the time of acceptance (\$500 for non-residents; \$100 for residents) is required to hold a position in the class.

TUITION AND FEES: Approximately \$26,900 non-resident; \$10,700 resident per year (subject to change).

ENTRANCE REQUIREMENTS: Priority is given to Oklahoma residents. Admission of non-resident applicants is limited to 24 positions, including 4 New Jersey residents. To be eligible for regular admission, applicants must complete all preveterinary course requirements. Applicants who do not meet all preveterinary course requirements, but have completed the BS/BA/MS or PhD degree in physical or biological sciences and possess excellent potential for distinguished performance in the veterinary medical profession, may qualify for admission. For all applicants, scores from the **Graduate Record Examination (GRE®) General Test** and the **Biology Subject Test** are required, and the tests must be taken no later than the last available test date in December. (**GRE® Code 6558**). Tests must have been taken within the four years prior to application (June 2001). A minimum grade point average of 2.80 on a 4.00 scale is required for prerequisite courses. Any grade lower than C in a required course is unacceptable. Courses may be repeated but the hours and grade points earned in repeated courses will be averaged with those earned originally to arrive at the required course GPA. All coursework except humanities, social science, and English must have been completed within eight years of the fall semester for which application is made. The earliest semester to be counted for 2005 applicants (for 2006 admission) is fall 1997. Applicants must have satisfied all academic requirements by the last day of the spring term of the year in which admission is desired.

LETTERS OF EVALUATION: Applicants are required to have three recommendations in support of their application, one of which **must be from a veterinarian**. Others may be from an employer and/or academic advisor.

COURSE REQUIREMENTS: Prerequisite courses and semester credit hours for entrance into the college must include:

Elective(s) If all of the above courses do not total 60 credit hours, science and/or business electives may be used. Credit hours will vary according to institution in which coursework is completed.
